# New APA Boathouse Rules Update

### Second Proposal Fails to Pass

In response to a public outcry, the Adirondack Park Agency Board (APA) recently voted to revise currently proposed boathouse regulations; however, the vote resulted in 5 to 5 split. The new proposal sought to approve a revised definition that would cap a boathouse at 1,200 square feet in size and 15 feet in height and allow flat or pitched roofs. Because of the stalemate the proposal is being sent back to the APA's Legal Affairs Committee for further review.

. Public hearings on this issue held in January elicited hundreds of letters of opposition to the original proposal that would have a boathouse be no larger than 900 square feet and 15 feet or less in height. In addition, all rigid roof surfaces would have a minimum pitch of four on 12. These regulations would apply to new structures and existing structures planned for expansion. Modifications of existing structures exceeding the proposed parameters would require a variance.

### APA Redefines "Dock"

The Adirondack Park Agency (APA) Board recently voted to change the definition of the term "dock." The new regulation now requires that hoisted docks, suspended in the air, remain parallel to the water during the winter months and be no larger than 100 square feet in size.

Old photographs depict a time and place of elegance and good taste, which was reflected by guests who were affluent and socially prominent, including three U.S presidents. Today Loon Lakers are also blessed with Loon Lake's quality living and are beneficiaries of the beauty and unique architectural designs of the original buildings, each with its individual personality and name - names which have been retained to this day.

A testament to the appreciation of Loon Lake homeowners' preservation of their architectural treasures, is mirrored by Adirondack Architectural Heritage's (AARCH) inclusion of Loon Lake in its schedule of architectural tours for several years. In this connection, a small ad hoc committee of Loon Lake homeowners has been active in preparing for this year's tour, which, as in previous years, will include approximately 25-30 paying attendees. The Loon Lake Homeowners' Association (LLHA) will receive \$8.00 per person from the proceeds garnered by AARCH for this tour. This money is earmarked for addition to the LLHA's Invasive Species Monitoring Fund.

As mentioned in our last newsletter, a successful tour is dependent on the willingness of a certain number of owners of original Loon Lake cottages to open their historic edifices to the tour. The tour has been scheduled for Thursday, July 15.

# Subdivision Law Repealed. Planning Board Abolished

After two public hearings, the Town Board on two separate occasions voted to repeal the contentious subdivision law enacted by the previous Board last fall and to abolish the related planning board. The subdivision law required approval of any subdivision of five lots or more within a 10-year period. Consequently, Town subdivisions now remain largely regulated by the Adirondack Park Agency as previously.

Opponents of the subdivision law maintain that the law is unnecessary because it would be a duplication of Adirondack Park Agency (APA) regulations and would be costly for the Town to implement. Whereas, proponents point out that the APA does not have jurisdiction over hamlets regarding subdivisions.

A major item in the new Town board members' election campaign platform was their promise to review, revise or rescind the law.

### Town Roadside Cleanup Day Held

The town of Franklin had a roadside litter cleanup from 9 a.m. to 1 p.m. on Saturday, May 15.

Forty volunteers, young and old, met at the Franklin Town Hall on state Route 3 at 8:45 a.m., and returned at the town hall at 1 p. m. after having covered the area in and around the Vermontville and other areas, not including Loon Lake. It has been proposed by LLHA President Vince Pagano that volunteers from the Loon Lake Community participate in a roadside litter cleanup day in Loon Lake sometime during the summer season when more residents are available to join in the effort.

Coffee and donuts were available in the morning and hot dogs in the afternoon.



# Don't Pick up Hitchhikers

Aquatic nuisance species can hitch a ride on our clothing, boats, and items used in the water. Before bringing boats or other items used in another body of water to Loon Lake, employ the following simple procedure.

- Remove any visible mud, plants, fish or animals before transporting equipment
- Eliminate water from equipment before transporting
- Clean and dry anything that came in contact with water (Boats, trailers, equipment, clothes, dogs,

Never release plants, fish or animals into a body of water unless they came out of that body of water

#### Please be considerate by:

- Steering Clear of us, especially if we have chicks, when boating.
- Not driving us away from sheltered areas into open areas where boat traffic is heavy.
- > Using non-lead fishing sinkers and jigs.
- Packing out your line. Invisible in the water, lost or cut fishing line can entangle us and other wildlife, often with fatal results.


