2024 LOON LAKE SWIM BEACH & BOAT-LAUNCH BOAT STORAGE REGISTRATION

REGISTRATION FEE: \$25.00 per boat

These instructions are intended to provide homeowners with deeded lake rights the information they need to complete and submit the form for overnight parking of non-motorized boats at the Swim Beach and Boat-launch Beach. Examples of non-motorized boats include paddleboards, kayaks, canoes, and rowboats. Motorized boats are not allowed on the Swim Beach or Boat-launch properties or in the swimming area.

Overnight parking from May-October requires boats to be registered and have a LLHOA sticker. Only homeowners with deeded lake rights can register boats for overnight parking. The parking fee for homeowners' personal use is \$25 per non-motorized boat. The parking fee charged to homeowners who have renters using overnight parking is described below. Funds raised will be used to support the maintenance of these HOA owned Beaches.

You can register your nonmotorized watercraft(s) and submit the required fee by paper or online. In both cases you will need to complete the 2024 Annual Loon Lake Homeowners Association (LLHOA) Swim Beach and Boat-Launch Beach Non-Motorized Watercraft Overnight Parking Fee and Release of Liability Agreement Form (attached).

Step 1 - Complete Registration Form

- This form has been constructed as a fillable pdf which you can download to your computer either from the LLHOA website http://loonlakehoa.org/membership.html#boatpark or from this e-mail and fill out on your computer.
- Attach the form to an e-mail addressed to: <u>loonlakehoainformation@gmail.com</u>

Print the completed form (or print the form and complete with a pen) and mail to LLHOA, PO Box 219, Vermontville, NY 12989.

• Paper copies of this form will also be available in the new mailbox that will be located at the Swim Beach in early June. They can be mailed to the LLHOA address above.

Step 2 - Pay Registration Fee

Important Information for Homeowners who Rent:

All boats must have a sticker in order to park **one** or more days on either of the LLHOA beaches. Homeowners are responsible for paying the fee for any of their renters planning on leaving boats at either beach and providing those renters with the required parking sticker(s).

Homeowners' fee is based on the estimated number of boats/ stickers they will need for **renters who will park their own boats overnight**. For example, if the homeowners estimate they have 6 renters for the 2024 season, storing 2 boats each at one of the LLHOA beaches during their stay, the owner will need to obtain 12 stickers at a cost of \$300 for the summer. Additional stickers can be purchased later in the season, if needed. However, if the **renters are using the homeowner's boats** that have been registered and have a parking sticker, there would be NO additional cost. *The LLCA strongly encourages this option to help reduce the risk of introducing invasive species to our pristine waters! Also, please provide your renters with proper boat cleaning instructions if they are bringing their own boats.*

Parking Stickers:

In approximately one week following receipt of your registration and payment, the boat stickers you ordered will be placed in a personalized envelope in the mailbox on Swim Beach with the homeowner's name on it. All boat stickers will have the last name of the homeowner.

All boats must be removed from the LLHOA beach area by the end of October.
